





#### SKIP THE STUFF CASE STUDY: Borough of Red Bank

Restaurants providing single-use cutlery and condiments upon request only

## **SCOPE OF WORK**

Clean Water Action and Clean Water Fund's ReThink Disposable program helps to stop waste before it starts.

In March 2024, Red Bank passed their Skip the Stuff Ordinance (2024-08), which has restaurants only provide single-use cutlery and condiments upon request for take-out orders. This led nine other municipalities to pass similar ordinances in 2024.

Red Bank's Green Team, with the help of Clean Water Action, created educational flyers in English and Spanish and provided outreach to businesses and residents.

In November 2024, Clean Water Action visited twenty-nine (29) restaurants in Red Bank to gauge the success rate of the Skip the Stuff Ordinance.

Of the twenty-nine (29) restaurants visited, twenty (20) restaurants were able to provide data while nine (9) did not have managers present to provide financial information. In some cases, multiple visits were made to try to speak with the person in charge but that was not always possible.



## **MEASURING OUTCOMES**

Cutlery and Condiment Waste Reduction and Restaurant Savings



- 29 restaurants surveyed
- 20 restaurants provided data
- 9 restaurants did not provide data
- 4 restaurants were not following ordinance, either because their customers had no access to wash or it was a newly established business
- 75% reduction in single-use condiments and cutlery being provided to customers by all businesses who provided data

### 1,578,769 pieces

of toxic plastic cutlery (over 10,000 lbs) annually reduced from the waste stream as a result of 16 compliant restaurants in Red Bank

# 94% reduction

in single-use cutlery and condiments for all businesses following Skip the Stuff, equating to money saved
